For good and valuable consideration, this conditional sales contract is entered into between Pools by Ben, Inc. (PBB) and Pool Owner/Resident. PBB agrees to sell and the Pool Owner/Resident agrees to buy a variable speed pump on a conditional sale:

Pool Owner/Resident are both responsible for proper operation of the equipment, safely securing the equipment at the property, and immediately notifying PBB of any suspected problems with the equipment. The equipment carries a manufacturer’s warranty. This contract does not change the manufacturer’s warranty. If equipment is damaged due to physical force or negligence, or if equipment is missing, the Pool Owner/Resident will be charged the lesser of the cost of repairs or the balance of the payments due. Damage to the key pad from leaving the cover open is considered negligence. No pump operates without water. Damage from operating a pump without water is the Resident and/or Pool Owner’s responsibility. The Pool Owner/Resident agrees not to remove the equipment from the above address without the written consent of PBB.

The entire balance shall become immediately due upon default on any installment due or other breach of this agreement. In the event of a default, PBB may enter upon the premises of the Pool Owner/Resident and reclaim said goods. In the event of default, Pool Owner/Resident shall be responsible to pay attorney fees, collection costs, and other fees associated with enforcement of this agreement. This agreement is binding upon and inure to the benefit of the parties, their successors, assignees, and personal representatives.
